

KENT TRANSFER STATION PERMIT APPLICATION

DEAR TRANSFER STATION USER:

USE OF THE TRANSFER STATION IS BY PERMIT ONLY. PERMITEE IS ENTITLED TO DELIVER HOUSEHOLD WASTE FROM ONLY ONE KENT HOUSEHOLD.

PERMITS ARE GOOD FOR ONE YEAR. THEY ARE ISSUED FOR THE PERIOD OF JULY 1 THROUGH JUNE 30 OF EACH YEAR. THE COST FOR EACH PERMIT IS \$150. THIS FEE IS NOT PRORATED. THERE IS A \$20 SENIOR DISCOUNT AVAILABLE TO RESIDENTS 65 YEARS OF AGE OR OLDER WHO PRESENT IDENTIFICATION AND REQUEST THE DISCOUNT.

PERMITS CAN BE PURCHASED AT THE SELECTMEN'S OFFICE DURING NORMAL BUSINESS HOURS:

MONDAY THROUGH FRIDAY 9 AM – NOON AND 1:00 PM – 4:00 PM
OR YOU MAY MAIL A COMPLETED APPLICATION AND A CHECK ALONG WITH A SELF ADDRESSED ENVELOPE TO:

THE PERMIT TAG SHOULD HANG ON THE VEHICLE'S REARVIEW MIRROR TO BE VISIBLE BY THE STATION ATTENDANT. THERE IS A \$5 FEE TO REPLACE LOST OR DAMAGED TAGS. THE ATTENDANT IS THERE TO SUPERVISE THE OPERATION OF THE TRANSFER STATION

THE TRANSFER STATION IS LOCATED ON MAPLE STREET (ROUTE 341 EAST). THE ENTRANCE USES THE SAME ROAD THAT SERVES THE KENT. THE TRANSFER STATION IS OPEN:
SATURDAY AND SUNDAY
FROM 8:00 AM – 3:30 PM.
